

1. Entry fee is \$120.00 per boat if paid by May 3, 2010. Any entries after May 3, 2010 will have an entry fee of \$170.00. All entries are final. Sorry, no refunds.
2. The Tournament will be held from May 14, 2010, 12:00 Noon (line in water) until the close of the weigh-in-scale 2:00 pm on Saturday, May 15, 2010. Weather dates will be May 15 & 16, 2009.
3. Each boat is allowed up to (4) anglers, this includes the captain. Only the signed in anglers may fish, no substitutes.
4. All fishing must comply with "IGFA" International Game Fish Association rules.
5. A Captain's meeting will be held on Thursday, May 13, 2010, at Atkinson's Tavern, starting at 6:00 PM, to review rules, issue boat numbers and answer your questions. Boat numbers must be displayed on the STARBOARD side of your boat.

8. In the event of more than one fish weighing the same, first fish at weigh in will be the winner. If no drum fish are weighed in, boat numbers will be drawn as the winners. Drawing will be held at 2:00 pm at Smokey's Marina.
9. The weather makeup days are May 15 & 16, 2010.
10. All VHF radio communications between judges, committee boats and contestants will be on Channel 68.
11. Weigh-ins will be held at Smokey's Marina, 300 Beach Avenue, Reeds Beach. Weigh-in will be Saturday, May 15, 2010, 9:00 am to 2:00 pm. Participants must be in line no later than 2:00 PM to be eligible for weigh in.

12. All fish will be subject to examinations externally and/or internally, or as any judge deems necessary. Any fish entered in the contest is subject to disqualification if a judge decides it bears suspicious marks or characteristics. All winning fish will be internally inspected. All decisions by the judges are final.
13. At no time is any boat permitted to approach another boat, structure or land. If this rule is broken, the entrant will be disqualified and his fee forfeited. Verified emergencies are accepted.
